Extraordinary assessment session

We consider **two possible scenarios in September** (depending on the evolution of the COVID19 situation):

A. In case of face-to-face exam session:

Extraordinary assessment session will take place in September. Date and room for the extraordinary assessment session will be fixed at least 15 days in advance and will be communicated in PRADO.

Percentages of overall mark (100%):

- Written exam consisting in 10 shorts questions about the papers and materials used during the classes (50%)
- To solve a case study given by the professors about one topic related to the subject (50%)

B. In case of distance mode in September:

Extraordinary assessment will consist of an online session in PRADO, and will take place in September. Date of the extraordinary assessment session will be fixed at least 15 days in advance and will be communicated in PRADO, along with a list of instructions for the development of the online session.

Percentages of overall mark (100%):

- Online oral examination by Google Meet with 5 objective questions referred to the theoretical content of the subject (50%).
- Online practical exam (in PRADO) with several practical questions about a case study given by the professors in which apply the knowledge acquired (50%)
